I understand that if selected as the 2025 Nevada State High School Rodeo Association Queen, I will be expected to perform duties on behalf of the NSHSRA which includes attending and competing in the National High School Rodeo Finals Queen Contest at the Sweetwater Events Center, Rock Springs, WY from July 9<sup>th</sup> to the 19<sup>th</sup> special events and Royalty fundraisers. I also agree to attend and to make presentation runs at a minimum of eight qualifying high school rodeos. I will also participate in parades and other rodeos or events within my own state as a representative of the NSHSRA during the year of my reign.

If I am chosen as the Nevada State High School Rodeo Association 1<sup>st</sup> Attendant, I understand that I will be expected to perform duties on behalf of the NSHSRA which include attending and competing in the 2025 Silver State International Queen Contest as NSHSRA 1<sup>st</sup> Attendant, on June 30<sup>th</sup> through July 7<sup>th</sup>, 2025, in Winnemucca Nevada. Also attend any and all Royalty fundraisers. I also agree to attend and to make presentation runs at a minimum of eight qualifying high school rodeos. I will also participate in parades and other rodeos or events within my own state as a representative of the NSHSRA during the year of my reign.

If for any reason, the Queen is unable to attend the National High School Rodeo Finals and I am chosen as the 1<sup>st</sup> Attendant to the Queen, I understand that I will be required to take her place by attending and competing in the NSHSRA Finals Queen contest. I also understand that in doing so it does not entitle me to assume the position or any prizes that she may have received when crowned Miss NSHSRA Queen.

I understand that if selected as the 2025 Nevada State Junior High School Association Princess, I will be expected to perform duties on behalf of the NSJHSRA, such as Royalty fundraisers. I also agree to attend and to make presentation runs at a minimum of eight qualifying high school rodeos. I understand that I can, but am not required, to participate in parades, local rodeos, or other events within my own state as a representative of the NSJHSRA during the year of my reign.

In addition to these mandatory functions- I also agree to:

Wear my crown, sash, and buckle at all functions.

Be responsible for all my own expenses while serving in this position.

Have a pre-arranged chaperone at all events, which is usually a parent or guardian. Maintain close contact with the NSHSRA Queen Coordinator, providing her with a monthly itinerary of my appearances and posting regularly to the Miss Nevada High School Rodeo Facebook page, I also understand that my travel expenses may not be reimbursed for these appearances.

Dress in western attire (Cinch/ Cruel Girl, American Hat) and to represent the rodeo industry in a professional courteous manner while always maintaining a high moral character.

Be open and friendly to the public and be willing to promote the NSHSRA or the NSJHSRA at events, such as parades, Cowboy Poetry contest, local / county/ college or PRCA fairs and rodeos, Miss Rodeo America and Finals Rodeo.

Be 15 minutes early for all events and functions.

Strive to improve my skills in the rodeo events that I participate in, in addition to continuing to work on my horsemanship, riding ability, appearance and personality.

Not drink alcoholic beverages or take illegal drugs at any time during my reign as Miss NSHSRA Queen, Attendant or Princess

Keep all Social Media that I am involved with appropriate and (even if it is not rodeo related). This holds especially true on the Queen's Facebook page.

Be an active participant in the NSHSRA Student Board (Queen only) and attend all scheduled Board Meetings (Queen) held throughout the year as 1<sup>st</sup> Attendant and Princess, I understand that I can attend these meetings as a member of the Royalty committee and student athlete and that I will not have any voting rights.

Complete my reign by attending the 2026 NSHSRA and NSJHSRA Finals and to act as hostess to the visitors and next year's royalty contestants.

Attend the Royalty contest events held during the week of State Finals

- I will organize the Meet and Greet event.
- I will emcee the Modeling, Speech and Impromptu portions of the competition
- I will attend and help present all awards at each award ceremony

All paperwork including the: Constant Agreement, photos and biography/contestant info MUST be postmarked (priority mail is highly recommended) by May 1, 2025.

Contestants will sign as a testament of understanding the rules and expectations. If there are any questions, please do not hesitate to ask for clarification.

I understand that, as Queen, the Miss Nevada State High School Rodeo title is the ONLY royalty position that I can hold during my reign and that all others must be relinquished by August 31<sup>st</sup> of this year. Any other title won during the year of the NSHSRA reign must not start until July 1<sup>st</sup> of the following year.

I understand that all decisions of the judges are final.

I understand that there are certain risks and dangers involved in competing in the NSHSRSA and NSJHSRA Queen contest and hereby assume all risks of injury sustained to my person, of damage or loss to my property during or resulting from my participation in the contest.

I hereby release the NSHSRA and NSJHSRA, its members and affiliates from all claims, demands, actions, and causes of action of any sort pertaining to any injury to my person or any damage or loss to my property during or resulting in my participation in this contest.
