

Nevada State High School Rodeo Finals 2026 Queen Royalty Agreement for Applicants

I understand that if selected as the 2026 Nevada State High School Rodeo Association Queen, I will be expected to perform duties on behalf of the NSHSRA which includes attending and competing in the 2026 National High School Finals Rodeo Queen Contest, July 15-25, 2026 Sandhills Global Event Center, 4100 N 84th St, Lincoln, NE 68507. This also includes specialty events and royalty fundraisers throughout the 2026-2027 season. I also agree to attend and to make presentation runs at a minimum of eight qualifying high school rodeos. I will also participate in parades and other rodeos or events within my own state as a representative of the NSHSRA during the year of my reign.

To compete for the title I meet the minimum requirements in the rule book and state bylaws/approved votes in meetings:

- In the current rodeo year, I have or will have attended and entered a minimum 1 event in 5 different Nevada High School Rodeos prior to competing for this title.
- I am currently in and finishing this year 9th, 10th or 11th grade in high school.
- I am a member in good standing of Nevada High School Rodeo and National High School Rodeo Association.

If I am chosen as the Nevada State High School Rodeo Association 1st Attendant, I understand that I will be expected to perform duties on behalf of the NSHSRA which include attending and competing in the 2026 Silver State International Queen Contest as NSHSRA 1st Attendant, on June 30, 2026 through July 7, 2026 in Winnemucca, Nevada. Also, to attend any and all Royalty Fundraisers. I agree to attend and to make presentation runs at a minimum of eight qualifying high school rodeos during the 2026-2027 rodeo year. I will also participate in parades and other rodeos or events within my own state as a representative of the NSHSRA during the year of my reign.

If for any reason, the Queen is unable to attend the National High School Rodeo Finals and I am chosen as the 1st Attendant to the Queen, I understand that I will be required to take her place by attending and competing in the NHSRA Finals Queen contest. I also understand that in doing so it does not entitle me to assume the position or any prizes that she may have received when crowned Miss NSHSRA Queen.

In addition to these mandatory functions - I also agree to:

Wear my crown, sash, and buckle at all functions.

Be responsible for all my own expenses while serving in this position.

Have a pre-arranged chaperone at all events, which is usually a parent or guardian. Maintain close contact with the NSHSRA Queen Coordinator, providing her with a monthly itinerary of my appearances and post regularly to the Miss Nevada High School Rodeo Facebook page. I also understand that my travel expenses may not be reimbursed for these appearances.

Dress in western attire appropriate for the venue you are attending (Cinch/Cruel Girl, American Hat, etc highlighting sponsors when possible) and to represent the rodeo industry in a professional courteous manner while always maintaining a high moral character.

Be open and friendly to the public and be willing to promote the NSHSRA at events, such as parades, Cowboy Poetry contest, local/county/college or PRCA fairs and rodeos, Miss Rodeo America and Finals Rodeo.

Be punctual and respectful of start times for all events and functions.

Strive to improve my skills in the rodeo events in which I participate, continue to work on my horsemanship, riding ability, appearance and personality.

Not drink alcoholic beverages or take any illegal drugs at any time during my reign as Miss NSHSRA Queen or 1st Attendee.

Keep all social media that I am involved with appropriate (even if it is not rodeo related). This holds especially true on the Miss Nevada High School Rodeo Queen's Facebook page.

If I receive the title of NSHSRA Queen, I will be an active participant in the NSHSRA Student Board and attend all scheduled board meetings held throughout the year. As Queen I will have a vote.

If I receive the 1st Attendant, I understand that I can attend these meetings as a member of the Royalty Committee and student athlete and that I will not have any voting rights.

I will complete my reign by attending the 2027 Nevada State High School Rodeo Association State Finals and to act as hostess to the visitors and next year's royalty contestants, unless I am competing.

Attend the Royalty contest events held during the week of State Finals.

- I will organize the meet and greet event
- I will emcee the Modeling, Speech and Impromptu portions of the competition
- I will attend and help with the Student Board to present all awards at each award ceremony
(*This excludes any contestant competing for a title at State Finals*)

All paperwork including the contestant agreement, photos, and biography/contestant info MUST be postmarked (priority mail is highly recommended) by May 1, 2026.

I understand that if any information is missing from my packet my entry will be denied, and I will not be eligible for competition.

Any applications postmarked after May 1, 2026 deadline, I will not be able to compete.

Contestants will sign as a testament to her understanding of the rules and expectation. If there are any questions, please do not hesitate to ask for clarification.

I understand that, as Queen, the Miss Nevada State High School Rodeo title is the ONLY royalty position that I can hold during my reign and that all other titles must be relinquished by May 19, 2026. Any other titles won during the year of the NSHSRA reign must not start until June 1, 2027.

I understand that all decisions of the judges are final.

I understand that there are risks involved in competing in the NSHRSA Queen contestant and hereby assume all risks of injury sustained to my person, of damages or loss to my property during or resulting from my participation in the contest.

I hereby release the NSHSRA, its members and affiliates from all claims, demands, actions, and causes of action of any sort pertaining to any injury to my person or any damage or loss to my property during or resulting in my participation in this contest.
